Dottie will look into what it will cost to have the fire alarm system notify the fire department. Bob offered to assist with this.

**New video conferencing system** – The new video conferencing system purchased by the library was reported to be simple to use. It is being used for the Board meeting tonight and is used by other groups for their meetings at the library.

**New computer** – Dottie reported there is money in the budget to replace the computer that is greater than 5 years old per the OWWL system technology department recommendation. She will go ahead with this.

**Hispanic Digital Literacy Classes** – The library partnered with Literacy Volunteers of Wayne County to provide digital literacy classes in Spanish for the community. The classes are being paid for by a grant from ATT and the American Public Library Association. The six classes ended as of this past Monday.
